## 5 Associated standards and special regulations

1 General<br/>requirementsSuppliers of hydraulic equipment or machinery in which hydraulic equipment is included are<br/>responsible for ensuring that the equipment meets the requirements made by the authorities<br/>for safety and the requirements made by the purchaser for function and reliability.

Hydraulic equipment should, as far as possible, be delivered separately from the supplied machinery.

The tenderer/supplier shall follow these technical regulations and whenever this should prove impossible shall specify the points at which deviations must be made. The deviations shall be approved by the purchaser.

## 2 Documentation

2.1 General regulations Drawings shall be executed with Swedish text on transparent plastic film in standard format, maximum A1; circuit diagrams for electric equipment shall, however, always be drawn on standard format A3. Transparent copies of assembly drawings, diagrams, lists etc. belonging to equipment, in accordance with Subsections 2.2, 2.3, 2.4, 2.5 and 2.6 below, shall be included in delivery and shall be submitted to the purchaser in good time before the plant is taken into operation.

The purchaser retains the right to provide instructions concerning the execution of and changes in drawings when checking drawings after an order has been placed. The supplier shall insert all changes on the original drawings.Transparent copies of these drawings shall be submitted to the purchaser after the equipment has been commissioned and approved.
